Specificity	Rabbit anti SP-1 Glycoprotein antibody recogniszes SP-1 also known as Schwangerschaft's protein 1 or pregnancy $\beta$ 1glycoprotein, a glycoprotein marker synthesized in the syncytrotrophoblast of the placenta and secreted into maternal circulation as gestation progresses (Griffiths and Godard 1981). SP-1 glycoprotein has been extensively investigated as an indicator of pregnancy affected by trisomy, particularly as an idicator of down's syndrome affected pregnancy where it appears that maternal levels of SP-1 glycoprotein are significantly elevated compared to uneventful pregnancy (Bartels et al. 1988).
Storage	This product is shipped at ambient temperature. It is recommended to aliquot and store at -20°C on receipt. When thawed, aliquot the sample as needed. Keep aliquots at 2-8°C for short term use (up to 4 weeks) and store the remaining aliquots at -20°C.
	Avoid repeated freezing and thawing as this may denature the antibody. Storage in frost-free freezers is not recommended.
