Specificity **Rabbit anti dexamethasone hemisuccinate antibody** recognizes dexamethasone hemisuccinate, a synthetic steroid hormone, often used as an immunosuppressant or anti-inflammatory. This antibody exhibits the following cross-reactivities. At 100mM Dexamethasone:

ELISA This antibody has been tested in direct ELISA using Dexamethasone-thyroglobulin (2µg/ml) conjugate to coat the plate.

Storage This product is shipped at ambient temperature. It is recommended to aliquot and store at -20°C on receipt. When thawed, aliquot the sample as needed. Keep aliquots at 2-8°C for short term use (up to 4 weeks) and store the remaining aliquots at -20°C.

Avoid repeated freezing and thawing as this may denature the antibody. Storage in frost-free freezers is not recommended.
