Specificity	Rabbit anti Human BRCA1 antibody recognizes breast cancer type 1 susceptibility protein also known as BRCA1, Breast Cancer 1 or RING finger protein 53. BRCA1 is a tumour suppressor gene which is involved in the repair of damaged DNA. BRCA1 protein inhibits the growth of cells lining the milk ducts in the breast and is often used as a diagnostic marker for breast cancer.
Storage	Store at -20°C only.  Storage in frost-free freezers is not recommended.  This product should be stored undiluted. Avoid repeated freezing and thawing as this may denature the antibody. Should this product contain a precipitate we recommend microcentrifugation before use.
