The nature of these changes is dependent upon the duration of exposure to and/or withdrawal from phencyclidine. It is used as an anesthetic by veterinarians and is illicitly taken for its hallucinogen effects.
Storage	Store at +4°C or at -20°C if preferred.
	Storage in frost-free freezers is not recommended.
	This product should be stored undiluted. Avoid repeated freezing and thawing as this may
	denature the antibody. Should this product contain a precipitate we recommend
	microcentrifugation before use.
