Goat anti Pig IgG (Fc) has not been species cross adsorbed and may react with the Fc region of IgG from other species.</p> <p>Goat anti Pig IgG (Fc) antibody has been used extensively as a detection reagent for porcine IgG in ELISA, for example monitoring of the IgG response in influenza infected pigs (<a href="#">Crisci et al. 2013</a>).</p>
