Specificity

Rabbit anti PIDD antibody recognizes PIDD also known as p53-induced death domain protein 1. PIDD is a scaffold protein that interacts with both pro-death and pro-survival proteins following DNA damage. PIDD undergoes cleavage producing several smaller fragments which bind to either pro-death or pro-survival signaling molecules.

Western Blotting

Rabbit anti PIDD antibody detects a band of approximately 110 kDa in cell lysates under reducing conditions

Storage

Store at -20°C
Storage in frost-free freezers is not recommended.
This product should be stored undiluted. Avoid repeated freezing and thawing as this may denature the antibody. Should this product contain a precipitate we recommend microcentrifugation before use.
