Specificity	Rabbit anti SMAD1 antibody recognizes SMAD1, also known as mothers against decapentaplegic homolog 1 and transforming growth factor-beta-signaling protein 1. SMAD1 is a transcription factor and belongs to the dwarfin/SMAD family and is activated by bone morphogenetic proteins (BMP) to modulate transcription.
Western Blotting	Rabbit anti SMAD1 antibody detects a band of approximately 52 kDa in cell lysates and tissue lysates under reducing conditions
Storage	Store at -20°C Storage in frost-free freezers is not recommended. This product should be stored undiluted. Avoid repeated freezing and thawing as this may denature the antibody. Should this product contain a precipitate we recommend microcentrifugation before use.
