Specificity **Rabbit anti STAT5A (pSer780) antibody** recognizes STAT5A, also known as when phosphorylated at serine 780. STAT5A is a member of the STAT family of transcription factors. Members of the STAT family reside in the cytosol until activated. Upon activation STATs dimerize

and translocate to the nucleus where they exert their transcriptional effects. Serine residue 780 is located in the transcriptional activation domain of STAT5A.

Storage	Store at -20°C Storage in frost-free freezers is not recommended. This product should be stored undiluted. Avoid repeated freezing and thawing as this may denature the antibody. Should this product contain a precipitate we recommend microcentrifugation before use.
