Specificity	Chicken anti Rabbit Interleukin-13 recognizes rabbit interleukin-13 (IL-13). Rabbit interleukin-13 is an immunoregulatory cytokine produced by activated T helper type 2 (Th2) cells. IL-13 induces the expression of 15-lipoxygenase and leads to production of vasodilatory eicosanoids (Tang et al. 2003). Rabbits exposed to IL-13 showed increased airway hyperresponsiveness and inflammation (Josephson et al. 2012).
ELISA	This product may be used as a capture antibody in a sandwich ELISA together with AHP2825B as the detection reagent. PRABP010 may be used as a standard.
Storage	Store at +4°C. DO NOT FREEZE. This product should be stored undiluted. Should this product contain a precipitate we recommend microcentrifugation before use.
