Specificity	Rabbit anti Human STAG1 antibody recognizes stromal antigen 1 (STAG1), also known as cohesin subunit SA1.
	STAG1 is a subunit of the cohesin complex that regulates sister chromatid cohesion and DNA looping and plays role in spindle pole assembly and chromatid cleavage in anaphase of mitosis ( <u>Zhang et al. 2013</u> ).
Storage	This product is shipped at ambient temperature. It is recommended to aliquot and store at -20°C on receipt. When thawed, aliquot the sample as needed. Keep aliquots at 2-8°C for short term use (up to 4 weeks) and store the remaining aliquots at -20°C.
	Avoid repeated freezing and thawing as this may denature the antibody. Storage in frost-free freezers is not recommended. Should this product contain a precipitate we recommend microcentrifugation before use.
