Specificity **Rabbit anti Human SPT16 antibody** recognizes FACT complex subunit SPT16.

SPT16 is part of the FACT (facilitates chromatin transcription) complex that specifically interacts with histones H2A/H2B to initiate nucleosome disassembly and transcription elongation ([Abe et al. 2011](#)). SPT16 has been shown to be essential for nucleosome disruption and assembly on individual rDNA genes. Mutations in SPT16 result in defective nucleosome disruption and inability to fully activate pol I transcription when cells exit the S phase of the cell cycle ([Johnson et al. 2013](#)).

Storage This product is shipped at ambient temperature. It is recommended to aliquot and store at -20°C on receipt. When thawed, aliquot the sample as needed. Keep aliquots at 2-8°C for short term use (up to 4 weeks) and store the remaining aliquots at -20°C.

Avoid repeated freezing and thawing as this may denature the antibody. Storage in frost-free freezers is not recommended. Should this product contain a precipitate we recommend microcentrifugation before use.
