Specificity	<b>Human Anti-Adalimumab Antibody, clone AbD18654_hlgG1</b> , is a high affinity anti-idiotypic antibody that specifically recognizes the adalimumab monoclonal antibody and inhibits the binding of adalimumab to its target, TNFα. The antibody can be used to measure the levels of adalimumab and biosimilar products in bioanalytical assays. Clone AbD18654_hlgG1 can be used to develop and calibrate immune response assays
	to measure the anti-drug antibody (ADA) response in patient serum.
	Adalimumab (branded as Humira) is a fully human monoclonal antibody (IgG1/kappa) approved for the treatment of ankylosing spondylitis, Crohn's disease, psoriasis and several forms of arthritis. The antibody is specific for TNF $\alpha$ , and acts by blocking the activation of TNF receptors by TNF $\alpha$ . This inactivation down-regulates the inflammatory reactions associated with autoimmune diseases.

Affinity	The intrinsic affinity of the monovalent form of this antibody is $K_D$ =0.15 nM as measured by real time, label-free molecular interaction analysis on immobilized Adalimumab.
ELISA	This product may be used in an indirect ELISA or, when conjugated to HRP, as a detection reagent in a bridging ELISA together with <u>HCA202</u> as the capture reagent. Protocol: <u>PK bridging ELISA to measure free drug</u> .This antibody is fully human and can be used as a reference standard in an ADA assay. Protocol: <u>ADA bridging ELISA</u> .
Storage	This product is shipped at ambient temperature. It is recommended to aliquot and store at -20°C on receipt. When thawed, aliquot the sample as needed. Keep aliquots at 2-8°C for short term use (up to 4 weeks) and store the remaining aliquots at -20°C.
	Avoid repeated freezing and thawing as this may denature the antibody. Storage in frost-free freezers is not recommended.
