Specificity	Human Anti-Adalimumab Antibody, clone AbD18654_hlgG1, is a high affinity anti-idiotypic antibody that specifically recognizes the adalimumab monoclonal antibody and inhibits the binding of adalimumab to its target, TNFα. The antibody can be used to measure the levels of adalimumab and biosimilar products in bioanalytical assays.  Clone AbD18654_hlgG1 can be used to develop and calibrate immune response assays to measure the anti-drug antibody (ADA) response in patient serum.
	Adalimumab (branded as Humira) is a fully human monoclonal antibody (lgG1/kappa) approved for the treatment of ankylosing spondylitis, Crohn's disease, psoriasis and several forms of arthritis. The antibody is specific for TNF $\alpha$ , and acts by blocking the activation of TNF receptors by TNF $\alpha$ . This inactivation down-regulates the inflammatory reactions associated with autoimmune diseases.

Affinity	The monovalent intrinsic affinity of this antibody was measured as $K_D$ =0.15 nM by real time, label-free molecular interaction analysis on immobilized Adalimumab.
