# Specificity

**Human Anti-Ocrelizumab Antibody, clone AbD50989ia** is a paratope specific, inhibitory, anti-idiotypic antibody (Type 1) that specifically recognizes the free human monoclonal antibody drug ocrelizumab and its biosimilar products. Consequently, this antibody can be used to measure free ocrelizumab levels in serum from patients.

Clone AbD50989ia (HCA401) is a fully human recombinant monoclonal antibody with IgG1 isotype and is suitable as a positive control or calibrator in an anti-drug antibody (ADA) assay. It does not cross-react with the antibody drug rituximab (Rituxan).

Ocrelizumab (trade name Ocrevus) is a monoclonal IgG1/kappa antibody (VH3/κ1). In vitro, it binds to CD20 cell surface molecules on target cells thereby inducing immune effector mechanisms such as antibody-dependent cellular phagocytosis (ADCP), antibody-dependent cellular cytotoxicity (ADCC), complement-dependent cytotoxicity (CDC), and apoptosis. In vivo, ocrelizumab selectively and effectively depletes CD20<sup>+</sup> B cells. Hence, it is an immunosuppressive drug. Ocrelizumab is used to treat primary progressive multiple sclerosis and relapsing forms of multiple sclerosis in adults (including clinically isolated syndrome, relapsing-remitting disease, and active secondary progressive disease).

#### **Affinity**

The monovalent intrinsic affinity of Human anti-Ocrelizumab Antibody, clone AbD50989ia was measured as  $K_D = 0.7$  nM by real time, label-free molecular interaction analysis on immobilized ocrelizumab.

#### ELISA

This product may be used to develop and calibrate immune response assays to measure the anti-drug antibody (ADA) response in patient sera together with <u>HCA399</u> and <u>HCA400</u>.

#### Storage

This product is shipped at ambient temperature. It is recommended to aliquot and store at -20°C on receipt. When thawed, aliquot the sample as needed. Keep aliquots at 2-8°C for short term use (up to 4 weeks) and store the remaining aliquots at -20°C.

Avoid repeated freezing and thawing as this may denature the antibody. Storage in frost-free freezers is not recommended.
