# **Product Form**

Human IgG1 antibody (kappa light chain) selected from the HuCAL phage display library and expressed in a human cell line. This product is supplied as a liquid.

#### Specificity

**Human Anti-Sarilumab Antibody, clone AbD49516ia** is a paratope specific, inhibitory, anti-idiotypic antibody (Type 1) that specifically recognizes the free human monoclonal antibody drug sarilumab, and its biosimilar products. It does not recognize the drug target, the human Interleukin 6 receptor (IL-6R), nor sarilumab in complex with IL-6R. This antibody can be used to measure free sarilumab levels in serum from patients.

HCA411 is a fully human recombinant monoclonal antibody with IgG1 isotype and is suitable as a surrogate positive control or calibrator in an anti-drug antibody (ADA) assay. This antibody has a monovalent intrinsic affinity of 0.9nM and is one of the three antibodies offered for ADA assays. Antibody <u>HCA410</u> has an affinity of <0.1nM and <u>HCA412</u> has an affinity of 2nM.

Sarilumab (trade name Kevzara) is a humanized monoclonal antibody of the IgG1/kappa isotype that suppresses the inflammatory effects of interleukin-6 (IL-6) by binding to both membrane bound and soluble IL-6 receptor forms, thus blocking cis- and transinflammatory signaling cascades. Through this, sarilumab blocks the IL-6 signaling pathway (measured as STAT-3 inhibition). It is indicated for the treatment of moderate to severe reactive Rheumatoid Arthritis (RA) in adult patients who are irresponsive, respond inadequately or present intolerance to disease-modifying anti-rheumatic drugs (DMARDs) or tumor necrosis factor (TNF) antagonists. It is also indicated in combination with methotrexate (MTX) or as a monotherapy when there is intolerance to MTX or when MTX administration is inappropriate.

#### **Affinity**

The monovalent intrinsic affinity of Human Anti-Sarilumab Antibody, clone AbD49516ia was measured as  $K_D$  = 0.9 nM by real time, label-free molecular interaction analysis on immobilized sarilumab

### **ELISA**

Clone AbD49516ia can be used in indirect ELISA to detect sarilumab. It can also be used as a surrogate positive control or a calibrator in an anti-drug antibody (ADA) assay, together with <a href="https://example.com/hcA410"><u>HCA410</u></a> and <a href="https://example.com/hCA410"><u>HCA410</u></a>

#### **Storage**

This product is shipped at ambient temperature. It is recommended to aliquot and store at -20°C on receipt. When thawed, aliquot the sample as needed. Keep aliquots at 2-8°C for short term use (up to 4 weeks) and store the remaining aliquots at -20°C.

Avoid repeated freezing and thawing as this may denature the antibody. Storage in frost-free freezers is not recommended.
