Specificity	<p>Human Anti-Guselkumab Antibody, clone AbD59947ia is a paratope specific, inhibitory, anti-idiotypic antibody (Type 1) that specifically recognizes the free human monoclonal antibody drug guselkumab, and its biosimilar products. It does not recognize the drug target, the human Interleukin-23 (IL-23), nor guselkumab in complex with IL-23. This antibody can be used to measure free guselkumab levels in serum from patients.</p> <p>HCA421 is a fully human recombinant monoclonal antibody with IgG1 isotype and is suitable as a surrogate positive control or calibrator in an anti-drug antibody (ADA) assay. This antibody has a monovalent intrinsic affinity of <0.3nM for guselkumab and is one of the two antibodies offered for ADA assays. Antibody HCA420 has an affinity of 0.06nM for guselkumab.</p> <p>Guselkumab (trade name Tremfya) is a fully human monoclonal antibody of the IgG1/lambda isotype binding to the p19 subunit of IL-23 to block its interaction with the IL-23 receptor, subsequently inhibiting the release of pro-inflammatory cytokines and chemokines. Guselkumab is approved for the treatment of moderate to severe plaque psoriasis in adults.</p>
Affinity	<p>The monovalent intrinsic affinity of Human Anti-Guselkumab Antibody, clone AbD59947ia was measured as $K_D = 0.3 \text{ nM}$ by real time, label-free molecular interaction analysis on immobilized guselkumab</p>
ELISA	<p>Clone AbD59947ia can be used in indirect ELISA to detect guselkumab. It can also be used as a surrogate positive control or a calibrator in an anti-drug antibody (ADA) assay, together with HCA420.</p>
Storage	<p>This product is shipped at ambient temperature. It is recommended to aliquot and store at -20°C on receipt. When thawed, aliquot the sample as needed. Keep aliquots at 2-8°C for short term use (up to 4 weeks) and store the remaining aliquots at -20°C.</p> <p>Avoid repeated freezing and thawing as this may denature the antibody. Storage in frost-free freezers is not recommended.</p>
