Specificity

Human Anti-Benralizumab Antibody, clone AbD60095ia is a paratope specific, anti-idiotypic antibody (Type 1) that specifically recognizes the free human monoclonal antibody drug benralizumab. It does not recognize the drug target, human interleukin 5 receptor α (IL5R α), nor benralizumab in complex with IL5R α .

HCA426 is a fully human recombinant monoclonal antibody with IgG1 isotype and is suitable as a surrogate positive control or calibrator in an anti-drug antibody (ADA) assay. This antibody has a monovalent intrinsic affinity of 0.2nM and is one of the three antibodies offered for ADA assays. Antibody [HCA427](#) has an affinity of 4nM and [HCA428](#) has an affinity of 6nM.

Benralizumab (trade name Fasentra) is a humanized monoclonal antibody of the IgG1/kappa isotype that binds with high affinity to a conformationally distinct epitope within domain 1 of the α -chain of IL-5R, and thus inhibits proliferation of IL-5-dependent cell lines, and otherwise blocks signaling through the IL-5 receptor. Benralizumab is indicated as a maintenance treatment for severe asthma and an eosinophilic phenotype.

Affinity

The intrinsic affinity of the monovalent form of Human Anti-Benralizumab Antibody, clone AbD60095ia is $K_D = 0.2$ nM as measured by real time, label free molecular interaction analysis on immobilized benralizumab.

ELISA

Clone AbD60095ia can be used in indirect ELISA to detect benralizumab. It can also be used as a surrogate positive control or a calibrator in an anti-drug antibody (ADA) assay, together with [HCA427](#) and [HCA428](#).

Storage

This product is shipped at ambient temperature. It is recommended to aliquot and store at -20°C on receipt. When thawed, aliquot the sample as needed. Keep aliquots at 2-8°C for short term use (up to 4 weeks) and store the remaining aliquots at -20°C.

Avoid repeated freezing and thawing as this may denature the antibody. Storage in frost-free freezers is not recommended.
