Fusion Partners	Lymph node cells from an immunized rat were fused with cells of the mouse P3X63Ag.8.653 myeloma cell line.
Specificity	Rat anti Mouse CD38 antibody, clone 90 recognizes the murine CD38 cell surface antigen, a ~42-46kDa glycoprotein expressed by B lymphocytes, a proportion of peripheral T lymphocytes and by peritoneal macrophages.
	In the mouse CD38 is expressed by follicular B cells, is down regulated on germinal centre B cells, and not expressed by mature plasma cells. This pattern of expression contrasts strikingly with that seen in the human.
Flow Cytometry	Use 10ul of the suggested working dilution to label 10 ⁶ cells in 100ul.
