Specificity	Mouse anti Sheep CD14 monoclonal antibody, clone VPM66 recognises ovine CD14, a GPI-anchored ~55 kDa membrane glycoprotein and monocyte/macrophage differentiation antigen, belonging to the lipopolysaccharide receptor family. Ovine CD14 is expressed by monocytes, macrophages and peripheral blood granulocytes (Hopkins et. a 1996).			
	CD14 acts as a receptor for the potent bacterial endotoxin, lipopolysaccharide (LPS), facilitated by LPS-binding protein. The binding of LPS to CD14 results in cell activation, the release of cytokines and the inflammatory response, and has been shown to upregulate the cell surface expression of adhesion molecules.			
	Clone VPM66 has been shown to recognise CD14 in other domestic ruminant species including Water Buffalo (<i>Bubalus bubalis</i>) (<u>Vimos et. al. 1996</u>) and domestic cattle (<u>Hopkins et. al. 1996</u>). In addition to clone VPM66, clones <u>VPM65</u> and <u>VPM67</u> are also available.			
Flow Cytometry	Use 10ul of the suggested working dilution to label 10 ⁶ cells or cells or 100ul whole blood.

Storage

This product is shipped at ambient temperature. It is recommended to aliquot and store at -20°C on receipt. When thawed, aliquot the sample as needed. Keep aliquots at 2-8°C for short term use (up to 4 weeks) and store the remaining aliquots at -20°C.

Avoid repeated freezing and thawing as this may denature the antibody. Storage in frost-free freezers is not recommended.
