#### Specificity

**Mouse anti Rabbit light chain antibody, clone SB62a** only binds to the light chain of rabbit IgG and does not bind to the heavy chain. As such it can be used as a secondary antibody in western blotting, EIA and immunoprecipitation. This antibody is not

recommended for the direct detection of reduced or denatured rabbit chains on western blots.

<b>Storage</b>	Store at -20°C only. Storage in frost-free freezers is not recommended. This product should be stored undiluted. Avoid repeated freezing and thawing as this may denature the antibody. Should this product contain a precipitate we recommend microcentrifugation before use.
