Mouse anti Human p300 antibody, clone NM11 recognizes histone acetyltransferase p300, also known as E1A-associated protein p300, or EP300.

p300 is a histone acetyltransferase enzyme that regulates the transcription of genes via chromatin remodeling. It is crucial for the regulation of cell proliferation, cell differentiation and the prevention of the growth of cancerous tumors (<u>Ogryzko et al. 1996</u>) (<u>Pao et al. 2000</u>).

Storage

This product is shipped at ambient temperature. It is recommended to aliquot and store at -20°C on receipt. When thawed, aliquot the sample as needed. Keep aliquots at 2-8°C for short term use (up to 4 weeks) and store the remaining aliquots at -20°C.

Avoid repeated freezing and thawing as this may denature the antibody. Storage in frost-free freezers is not recommended. Should this product contain a precipitate we recommend microcentrifugation before use.
