Specificity	Mouse anti Human SHC3 antibody recognizes SHC-transforming protein 3, also known as protein Rai.
	SHC3 is an adaptor protein belonging to the SHC family and is thought to play a role in cell differentiation and cell survival (<u>Conti et al. 2001</u>). Downregulation of SHC3 results in aberrant levels of hypoxic signaling, inflammatory responses and apoptosis (<u>Ulivieri et al. 2016</u>). SHC3 is overexpressed in a number of different cancers (<u>Magrassi et al. 2005</u> , <u>Miyake et al. 2005</u> , <u>De Falco et al. 2005</u> , <u>Liu et al. 2018</u>).
Western Blotting	Mouse anti Human SHC3 antibody detects a band of 65 kDa in HeLa cell lysates
Storage	This product is shipped at ambient temperature. It is recommended to aliquot and store at -20°C on receipt. When thawed, aliquot the sample as needed. Keep aliquots at 2-8°C for short term use (up to 4 weeks) and store the remaining aliquots at -20°C.
	Avoid repeated freezing and thawing as this may denature the antibody. Storage in frost-free freezers is not recommended.
