Lambda light chains are distinguished from kappa light chains by multiple structural differences in their constant regions which contribute to differences to antibody specificity.

Storage This product is shipped at ambient temperature. It is recommended to aliquot and store at -20°C on receipt. When thawed, aliquot the sample as needed. Keep aliquots at 2-8°C for short term use (up to 4 weeks) and store the remaining aliquots at -20°C.
