<b>Specificity</b>	<p><b>Mouse anti Human ARAF antibody</b> recognizes the serine/threonine-protein kinase A-Raf, also known as oncogene ARAF1, Ras-binding protein DA-Raf and v-raf murine sarcoma 3611 viral oncogene homolog 1.</p> <p>This proto-oncogene belongs to the RAF subfamily of the Ser/Thr protein kinase family, and maybe involved in cell growth and development. Alternatively spliced transcript variants encoding different isoforms have been found for ARAF (provided by RefSeq, Jan 2012).</p> <p>Mouse anti Human ARAF antibody detects a band of 68 kDa. The antibody has been extensively validated for western blotting using whole cell lysates.</p>
<b>Western Blotting</b>	Anti ARAF detects a band of approximately 68 kDa in HEK293 cell lysates

<b>Lysate Reconstitution</b>	<p>- If using DDT reconstitute the lyophilized lysate with 190µl DI H<sub>2</sub>O, add 200µl 2x Laemmli Sample Buffer and 10µl 2M DTT.</p> <p>- If using BME reconstitute the lyophilized lysate with 180µl DI H<sub>2</sub>O, add 200µl 2x Laemmli Sample Buffer and 20µl BME.</p> <p>Heat at 95°C for 5 minutes. For 10 well mini gels load 25µl. For other gel and comb formats please refer to the PrecisionAb western blotting protocol.</p>
<b>Storage</b>	<p>Antibody: Store undiluted at -20°C, avoiding repeated freeze thaw cycles.</p> <p>Lysate: Store lyophilized lysate at -20°C. After reconstitution aliquot and store at -20°C for up to 3 months or at -80°C for longer term storage.</p>
