Specificity Mouse anti Human 14-3-3 epsilon antibody recognizes the 14-3-3 protein epsilon, also known as epididymis luminal protein 2, mitochondrial import stimulation factor L subunit, protein kinase C inhibitor protein-1, or tyrosine 3-monooxygenase/tryptophan 5-monooxygenase activation protein, epsilon polypeptide, or YWHAE. YWHAE gene product belongs to the 14-3-3 family of proteins which mediate signal transduction by

binding to phosphoserine-containing proteins. This highly conserved protein family is found in both plants and mammals, and this protein is 100% identical to the mouse ortholog. It interacts with CDC25 phosphatases, RAF1 and IRS1 proteins, suggesting its role in diverse biochemical activities related to signal transduction, such as cell division and regulation of insulin sensitivity. It has also been implicated in the pathogenesis of small cell lung cancer. Two transcript variants, one protein-coding and the other non-protein-coding, have been found for YWHAE (provided by RefSeq, Aug 2008).

Mouse anti Human 14-3-3 epsilon antibody detects a band of 28 kDa. The antibody has been extensively validated for western blotting using whole cell lysates.

Lysate Composition	400μg HEK293 lysate lyophilized in RIPA buffer
Lysate Reconstitution	- If using DDT reconstitute the lyophilized lysate with 190 μ l DI H $_2$ O, add 200 μ l 2x Laemmli Sample Buffer and 10 μ l 2M DTT.
	- If using BME reconstitute the lyophilized lysate with 180 μ l DI H $_2$ O, add 200 μ l 2x Laemmli Sample Buffer and 20 μ l BME.
	Heat at 95°C for 5 minutes. For 10 well mini gels load 25μl. For other gel and comb formats please refer to the PrecisionAb western blotting protocol.
Storage	Antibody: Store undiluted at -20°C, avoiding repeated freeze thaw cycles.
	Lysate: Store lyophilized lysate at -20°C. After reconstitution aliquot and store at -20°C for up to 3 months or at -80°C for longer term storage.
