Specificity	Rabbit anti Human FOXA1 antibody recognizes the hepatocyte nuclear factor 3-alpha, also known as HNF-3-alpha, HNF-3A, TCF-3A or transcription factor 3A.

The FOXA1 gene encodes a member of the forkhead class of DNA-binding proteins. These hepatocyte nuclear factors are transcriptional activators for liver-specific transcripts such as albumin and transthyretin, and they also interact with chromatin. Similar family members in mice have roles in the regulation of metabolism and in the differentiation of the pancreas and liver (provided by RefSeq, Jul 2008).

Rabbit anti Human FOXA1 antibody detects a band of 50 kDa. The antibody has been extensively validated for western blotting using whole cell lysates.

Lysate Reconstitution	- If using DDT reconstitute the lyophilized lysate with 190µl DI H ₂ O, add 200µl 2x Laemmli Sample Buffer and 10µl 2M DTT. - If using BME reconstitute the lyophilized lysate with 180µl DI H ₂ O, add 200µl 2x Laemmli Sample Buffer and 20µl BME. Heat at 95°C for 5 minutes. For 10 well mini gels load 25µl. For other gel and comb formats please refer to the PrecisionAb western blotting protocol.

Storage	Antibody: Store undiluted at -20°C, avoiding repeated freeze thaw cycles. Lysate: Store lyophilized lysate at -20°C. After reconstitution aliquot and store at -20°C for up to 3 months or at -80°C for longer term storage.
